



**Pengumuman Jadwal Pelaksanaan dan Tata Cara Pemecahan Saham ("Stock Split")
PT Jasuindo Tiga Perkasa Tbk ("JTPE")**

Berdasarkan hasil Rapat Umum Pemegang Saham Luar Biasa ("RUPSLB") yang diselenggarakan pada hari Rabu tanggal 29 Juni 2022, telah disetujui pemecahan nilai nominal saham (*stock split*) Perseroan dari sebelumnya Rp. 20,- setiap saham menjadi Rp. 5,- setiap sahamnya. Hal ini tertuang dalam Berita Acara Rapat Umum Pemegang Saham Luar Biasa PT. Jasuindo Tiga Perkasa Tbk nomor 45 tanggal 29 Juni 2022, serta perubahan pasal 4 ayat 1 dan ayat 2 Anggaran Dasar Perseroan yang tertuang dalam Pernyataan Keputusan Rapat PT. Jasuindo Tiga Perkasa Tbk nomor 6 tanggal 5 Juli 2022. Sehubungan dengan hal tersebut, berdasarkan surat dari PT Bursa Efek Indonesia nomor S-05961/BEI.PP2/07-2022 tanggal 18 Juli 2022 perihal persetujuan pencatatan efek, bersama ini kami sampaikan jadwal dan tata cara pemecahan *Stock Split* sebagai berikut :

Bagi Pemegang Saham yang sahamnya berada dalam penitipan kolektif KSEI, pelaksanaan *Stock Split* akan dilaksanakan berdasarkan saldo rekening efek pada akhir perdagangan saham di Bursa Efek Indonesia pada tanggal 29 Juli 2022 (*Recording Date*). Selanjutnya pada tanggal 1 Agustus 2022, saham hasil *Stock Split* akan didistribusikan melalui sub rekening efek masing-masing Pemegang Saham.
2. **Announcement of Schedule and Procedure of Stock Split
PT Jasuindo Tiga Perkasa Tbk ("JTPE")**

Based on results of the Extraordinary General Meeting of Shareholders ("EGMS") held on Wednesday, June 29, 2022, The Shareholders have approved the stock split from the previous IDR 20,- each share to IDR 5,- each share. This is stated in the Minutes of the Extraordinary General Meeting of Shareholders of PT. Jasuindo Tiga Perkasa Tbk number 45 dated June 29, 2022, as well as amendments to article 4 paragraph 1 and paragraph 2 of the Company's Articles of Association as stated in the Statement of Meeting Resolutions of PT. Jasuindo Tiga Perkasa Tbk number 6 dated July 5, 2022. Related to this, based on a letter from the Indonesia Stock Exchange ("IDX") number S-05961/BEI.PP2/07-2022 dated July 18, 2022 regarding the approval of the listing of share, we hereby convey the schedule and the procedure for the Stock Split as follows:

For Shareholders whose shares are in the collective custody of KSEI, the Stock Split will be executed based on the balance of the securities account at the end of the share trading on the Indonesia Stock Exchange on July 29, 2022 (Recording Date). Furthermore, on August 1, 2022, the shares resulting from the Stock Split will be distributed through the sub-accounts of each shareholder.
2.
